As you might know a motion for a recommendation on the elimination of discrimination based on sexual orientation has been put to the Parliamentarian Assembly of the Council of Europe.

The motion has been proposed by:

Inger Harms: Danish MP, socialist, chairman of the United Left Parties Inger Lise Gjørv: Norwegian, socialist, chairman of the Norwegian delegation

Miguelge Martinez: Spanish, socialist, vicepresident of the Assembly and maybe the next president

Peter Sager: Swiss, liberal chairman of the Swiss delegation Carl Ahrens: German, socialist, chairman of the socialist group

Verbeek: Dutch, liberal, chairman of the Dutch delegation

Bassinet: French, socialist, vicechairman of the French delegation

Noerens: Belgian, liberal, chairman of the Belgian delegation Tummers: Dutch, socialist, chairman of the Cultural Committee

Elmquist: Danish, liberal, chairman of the liberal group.

Since the proposal was put forward the two Danish members have left the CoE, but the new representative Ole Espersen (doctor and professor of law and former minister of justice) has promised to support the motion.

The procedure for adopting the protocol to the European Convention on the Protection of Human Rights and Fundamental Freedoms

- 1) The motion for a resolution has been put forward.
- 2) The motion will be considered in two committees of the Parliamentarian Assembly: The Social, Health and Family Committee adn The Committee on Legal Affairs and Human Rights. The committees will make a recommendation to the Parliamentarian Assembly.
- 3) The Assembly will (hopefully) pass the resolution.
- 4) At least one government shall take up the resolution and ask the Steering Committee on Human Rights to consider the resolution and (hopefully) produce a draft protocol.
- 5) The protocol shall be passed by at least 2/3 of the governments of the Council of Europe.
- 6) The protocol in then put forward for ratification in the member countries.
- 7) When ratified by 5 member countries the protocol comes into force (in these countries) and is still open for ratification of other members.

- 1) has happened
- 2) Members of the two parliamentarian committees (see enclosed list)
- 3) Mmebers of the Parliamentary Assembly
- 4) Governments (friendly ones) and members of the Steering Committee.
- 5) Governments (all)
