Good news on the CoE-front:

Mr. Elmquist has just told us that a motion for a recommendation has been presented to the secretariat of the Council of Europe. The motion is apart from some small language changes identical to the one discussed in Stockholm.

.../. An English and a French version is enclosed for your information. The motion has been signed by 10 members of the parliamentarian Assembly:

The next step will probably take place in Paris the 18th of January 1991, where the Presidium will send the motion to the committees.

But before that we will meet in Copenhagen the 27-31. of December and discuss the further lobby-efforts.


