A. Council of Europe Business

1) Additional protocol to the European Convention on Human Rights (prohibiting discrimination based on sexual orientation).

2) NGO status of ILGA to the Council of Europe

Ole Espersen has received letters from several members of the working party - thank you for that. LBL will arrange a meeting with him in the near future in order to explain to him once again the idea of the additional protocol to the convention of human rights. The resolution is not on the agenda of the next meeting of The Council of Europe in February 1993.

January 28-30 1993 there will be held a meeting organized by the CoE as a preparation to the World Conference on Human Rights. The meeting is called "Human Rights at the Dawn of the 21th Century". John Clark has asked for an invitation to ILGA to take part in the meeting. Further information is enclosed.

Furthermore we enclose a memo from Kurt Krickler about the UN world conference.

3) Lesbian and gay rights in Central- and Eastern European countries applying for membership of the Council of Europe

As far as the Russian application is concerned Ole Espersen (DK) and Daniel Tarschys (S) have promised to bring up the question of the Russian penal code. What about mr. Atkinson?

From Hein Verkerk we have received the enclosed list of the status of the central and eastern European countries relations to the CoE.

B. The CSCE - CHD process

The CSCE seminar on tolerance was held in Warsaw November 16 - 20 1992 with NGO participation. Kurt Krickler was present at the seminar.
