As mentioned in EUROLETTER no. 15 we have got a report from Geir Hagland of FHLA about the situation for gay men and lesbians in the Baltic countries. Geir has now sent a translation of the report into English. The report is enclosed.

Lithuania, Estonia and Slovenia have just been accepted as members of the Council of Europe on the 14th of May.

Alexander Modinos has won his case against Cyprus at the European Court of Human Rights in Strassbourg! Congratulations!!

Two list are enclosed: An update of Alexandra Dudas Comparison of the Legal Situation for Homosexuals in Europe and a list of members of the Committee of Legal Affairs of the Parliamentarian Assembly of the Council of Europe.

Austria is now chairman of the Council of Europe and has planned a human rights summit next October in Vienna. Our input to that summit will be discussed in Barcelona.

#### CSCE seminar on migration in Warsaw 19-23 April 1993

As mentioned in EUROLETTER no. 14 the LBL has produced an information package to the Danish delegation (in Danish) - but we did not participate in the seminar and we have not got any report back from the Danish delegation yet.

### CSCE seminar on minorities in Warsaw 24-28 May 1993

It has been confirmed that this seminar will only deal with national minorities - so there is no sense in ILGAs participation.

#### CSCE Bulletin

The CSCE office for Democratic Institutions and Human Rights in Warsaw has started publishing a periodical "CSCE Bulletin" - and thank to the Danish foreign ministry we will receive it. In the first volume an article about NGOs and the Human Dimension of the CSCE is published. A copy of that is enclosed for your information.

#### The report "Homosexuality - A European Community Issue" and the launch of it.

But as we did not get the report until the 12th May this was not possible. A launch with a press conference after the Danish referendum would be quite impossible as far as press coverage is concerned. So we decided to sent out a press release together with the book to the main Danish newspapers.
