## Removal of "sexual identity" phrase from draft antidiscrimination law in Turkey

The law proposal was prepared to protect Turkish citizens against discrimination and human rights violations against LGBT individuals. The removal of sexual identity ground from the proposal has been heavily criticised by Turkish LGBTI organisations, and ILGA-Europe reacted by sending a letter to Commissioner Füle of the European Commission expressing deep concern of the situation in Turkey.

# Steffen Jensen, member of the ILGA-Europe board 1996-2000



Steffen Jensen

Read the first personal testimonial in the celebration of the 15th Anniversary of ILGA-Europe - this time from one of the founders of ILGA-Europe, Steffen Jensen.

In the late 80's ILGA had established a working party dealing with European issues: the CoE/CSCE working party. It was dealing with issues around the Council of Europe and the Conference on Security and Cooperation in Europe (later the Organization for Security and Cooperation in Europe – OSCE). From the 1991 conference in Berlin an EC working party was also established, dealing with issues around the European Community (later the European Union).

The working parties consisted each of around 10-15 people from European countries and quite many were members of both working parties. I was part of both, and in all we were less than 20 people involved in the work, and we took care of lobbying the European institutions. The Euro-Letter was established in1990 as a common

information tool between members of the working parties and I was the editor until 2005.

I had taken part in all ILGA World and European conferences since 1986 and often been involved in changes of ILGA rules and together with my membership of the two working parties this was the background for my involvement in the establishment of ILGA-Europe.

And I am very proud of having taken part in that, because ILGA-Europe has really been a great success and is now a very respected international NGO with great influence on European policy concerning LGBT issues with close ties to all European institutions both at EU level and at Council of Europe level.

Among the most spectacular achievements of ILGA-Europe I will mention the inclusion of sexual orientation in the Amsterdam Treaty and the Framework directive on discrimination in the labour market.

Before the establishment of ILGA-Europe and before the Amsterdam Treaty it was nearly impossible for ILGA to get a positive dialogue with the European Commission and the Council of Ministers – only the Parliament would listen to us. This has really changed – and now ILGA Europe has close relations in all European institutions.

ILGA-Europe is – rightly – considered a very professional NGO always delivering very precise, relevant and to-the-point contributions. The main reason for that is of course the excellent staff we have been lucky to have.
