Liechtenstein referendum on same-sex partnership recognition: 69% in favor

Voters in Liechtenstein backed up overwhelmingly a law on registered partnership for same-sex couples in a referendum held Sunday 19 June 2011. The Parliament in Liechtenstein adopted earlier this year unanimously the law, but a submission of signatures was put forward to hold a referendum to change the decision.

The Slovenian Parliament adopted a new Family Code, with 43 votes in favor and 38 against. The new Family Code is however a compromise with right wing opposition and it brings only limited rights to samesex couples.

ILGA-Europe condemns violence and inadequate police actions at Split Pride

On 11 June 2011, the very first pride event in Split, Croatia, took place. ILGA-Europe's representatives took part in the event which turned violent and demonstrated inability and unwillingness of the police forces to ensure safety and to prevent violence.

ILGA-Europe at EuroPride 2011 in Rome, Italy

On 11 June 20 11, ILGA-Europe board members and staff participated to show their support. The EuroPride march was a big success, and ILGA-Europe was very visible and attracted significant attention with its flags, banners, signs in Italian/English calling for equality and human rights for everyone, a giant version of the latest Rainbow Europe Map. ILGA-Europe was moreover also given the opportunity to speak on the main stage after the performance of pop star Lady Gaga who delivered a strong speech supporting the equality for LGBTI people.

Podgorica Pride replaced by a Conference on LGBT Rights, Freedom of Expression and Assembly Podgorica Pride, which was planned to take place on the 31 May 2011, was postponed. Following the incidents during the IDAHO day event and the failure of the police to ensure the safety of the participant of the event, LGBT Forum Progress, the organiser of Podgorica Pride postponed the Pride, replacing it with a Conference on LGBT Rights, Freedom of Expression, Freedom of Assembly and/or Sexual Structural Stigma in Montenegro.

Pride events in Sofia, Budapest and Zagreb took place as planned

Despite obstacles and threats, all of the three Pride events went on as planned without major incidents. ILGA-Europe wrote an open letter the Bulgarian Prime Minister and the Mayor of Sofia urging them to rearrange the timing and the route of a nationalists' march scheduled for the same day/time as Sofia Pride March and close to its route. The Bulgarian authorities followed the request not to allow the nationalists' march at the same time/date with Sofia Pride. ILGA-Europe's representatives participated in Budapest Pride march and addressed its participants. Zagreb Pride took place just week after the violence in Split and therefore attracted additional attention. It went smoothly and was the largest Zagreb Pride ever. Austrian activists arrested in Hungary in connection with Budapest Pride

Two Austrian LGBT activists were put in custody overnight at the weekend after a group of locals accused the two men of having attacked them – however the Austrians claim that the local group attacked them with pepper spray. Police arrested the two men and they are now facing charges for disobedience.
