This second Declaration was accompanied by a report prepared by GenderDoc-M and ILGA-Europe detailing the language in question, which was circulated to many members of the Assembly.

On 20 June 2011 Members of Parliament of Ukraine have registered a draft Law of Ukraine "On Introduction of Changes to Certain Legislative Acts of Ukraine (regarding protection of children rights on the safe information sphere)", which has been heavily critized of being discriminatory towards LGBT people.

In June 2011, the Polish MEP Konrad Szymański (ECR) officially questioned the European Commission's involvement in the ILGA-Europe LGBT family exhibition 'Different Families Same Love'. The answer from the Commission was clear and was in support of ILGA-Europe and its activities to fight discrimination in the European Union.

The Ministry of Labor, Family and Social Affairs Republic of Slovenia took the groundbreaking decision after a dispute between the Center for Social Work and a lesbian woman who was requesting adoption of

Trans-inclusive Eurasian mechanism on HIV Prevention established

Earlier this month, the Eurasian Men's Health Coalition, EKOM was established. EKOM's mission is creation of supportive environment where any gay men or transgender person would have access to needed services in the field of sexual and reproductive health, first of all, HIV prevention, treatment, care and support that would be based on respect of and in line with human rights.

The Court of first instance of Rome reaffirmed that sterilisation is not to be understood as a mandatory requirement for gender reassignment. This decision will hopefully change the prevailing interpretation of the law in the country.

The statement noted the unanimous decision by the European Court of Human Rights last year that earlier prohibitions of Pride marches in Moscow violated the European Convention, and expressed grave concern at the manifest failure of the Russian Federation to respect the Convention, and at the damage that this is causing to the standing of the Council of Europe.
