A. Council of Europe

Additional protocol to the European Convention on Human Rights (prohibiting discrimination based on sexual orientation).

It was decided at the ILGA London meeting that the working party should write to the ten members of the Parliamentarian Assembly, who originally put forward the recommendation (as far as they still are members of the Assembly) asking them what is going on with the proposal. In Euroletter 22 groups were appointed to do that, but we have not received any information about any contact.

1. Romania

The situation is still not clarified. The proposal from the Juridical Committee has not been endorsed by the parliament, but is seems as if the parliament will pass a change of the law which will mean that homosexual activities causing "public scandal" will be an offense. See the attached annexes: Two press releases from IGLHRF and faxes from Scott Long and Alexandra Duda.

In the Halonen resolution a time limit of six month was set, and in February or March the Council of Europe will monitor the laws of Rumania. Please follow the suggestion from Alexandra Duda in her fax of 17 February 1994.

In a letter to LBL Ole Espersens has told that he has risen the question at a meeting in the Political Committee in such a way that the Romanian representative left the meeting!

The Danish foreign minister has expressed his support. But he also writes to us that he has received a letter from ILGA about the same issue. Who has written to the Danish minister of Foreign Affairs without informing us?? It is essential that our efforts are coordinated, and the whole idea with this Euroletter is that actions must be coordinated.

2. Albania, Moldova and Belarus

It was decided at the London meeting that the "Romania - mechanism" should be used on these three countries. Further information from Alexandra Duda is enclosed.

The Resolution on equal rights for homosexuals and lesbians in the EC

The EC bureau will draft an application (to be discussed within the Secretariats Committee) and try to get a co-sponsorship from WHO. We have not received any further information.
